Re: Consideration of awarding the Magnolia Park Playground project (Bid No.

23-B-008) to REP Services, Inc in the amount of \$226,154.05 as budgeted in the current fiscal year and funded by a 2022 Volusia County ECHO

(Environmental, Cultural, Historical, or Outdoor Recreation) Grant.

Date: April 3, 2023

On August 2, 2022, the Volusia County Council approved the City's ECHO Grand Award for \$243,750 for Magnolia Park Improvements. The ECHO grant is designed for Environmental, Cultural, Historical, or Outdoor Recreation projects and provides a fifty percent (50%) match of funds.

The Parks and Recreation Director put an enormous amount of effort into the application knowing how important it was to revitalize this underutilized park. The proposed improvements include the complete replacement of all playground equipment. It also includes the replacement of the entire boardwalk along the pond to maximize accessibility which was completed in March. Enhanced landscaping is scheduled to be installed along with a fence replacement and parking lot improvements. The pond will also be stocked to encourage fishing from the newly installed dock.

To facilitate the timely replacement of this equipment, staff utilized a bid process seeking contractors to replace the Playground with a Fishing Theme.

Although only one bid was received, staff has reviewed and has confirmed that pricing is fair and reasonable. The City has worked with Bliss Products and Services Inc in the past as they were the contractor for Riverfront Veterans Memorial Park.

Staff recommends awarding the Magnolia Park Playground project (Bid No. 23-B-008) to REP Services, Inc in the amount of \$226,154.05 as budgeted in the current fiscal year and funded by a 2022 Volusia County ECHO Grant.

If the project is awarded, construction is set to begin in Summer 2023.
