Re: Consideration of approving Volusia County's plan to disburse Justice

Assistance Grant (JAG) Funds they acquired to programs provided by SMA

Healthcare and The House Next Door

**Date:** April 21, 2023

The County receives funding from the Edward Byrne Memorial Justice Assistance Grant (JAG). The House Next Door was awarded grant funding but requested to withdraw their application. As a program requirement, the County must receive approval from 51% of cities located within Volusia County in order to reallocate funding. The City does not contribute any funds to this program; therefore, there is no fiscal impact with this agenda item. The City is being asked to simply concur with the County's recommendation on what to do with the funds they have received.

The JAG program focuses on providing funding to nonprofit organizations to improve the criminal justice system through one or more purpose areas. This includes, but is not limited to, programs focused on law enforcement, prosecution/court, prevention/education, drug treatment and enforcement programs. The County of Volusia is recommending funds in the amount of \$34,105 be allocated to SMA Healthcare, Inc. for an Adult Drug Court program from The House Next Door's Success by Design program.

The proposed letter certifies the City approves of the allocation of \$139,627 to SMA Healthcare, Inc.

Grant regulations require approval of the funding distribution by the majority of all local governments within the county. Volusia County has asked if the City would approve of their revised plan. If so, the Mayor would sign an approval letter that Volusia County has provided. This approval letter has been attached as Exhibit A to this memorandum and will be executed by the Mayor if the City Council approves.
