Re: Consideration of approving a proposal from Sparks Concrete for the milling

and resurfacing of Garfield Drive, Carey Drive, Wells Drive and Palm Grove Court utilizing a contract with Volusia County in the amount of \$206,328 as

budgeted in the current fiscal year.

Date: April 30, 2024

The current fiscal year budget was adopted in September 2023. Included in this budget were funds set aside for resurfacing, which is desperately needed due to the condition of our roadways. Now that we are debt free, the money we would have spent on interest payments can be spent on improving our infrastructure.

Phase I of our roadway resurfacing project for this year included Northern, Eastern, and Western Roads which were completed by Sparks Concrete in April 2024. The City divided this year's resurfacing project into phases because this was our first time utilizing this contractor for resurfacing and we wanted to make sure the quality was up to par. The contractor did an excellent job in Phase I so now we are ready to complete Phase II.

Phase II includes the resurfacing of Garfield Drive, Carey Drive, Wells Drive and Palm Grove Court. Garfield Drive was selected due to the numerous patches that have failed on this roadway which leads to South Daytona Elementary School. Carey Drive, Wells Drive and Palm Grove Court were chosen because these roadways were not resurfaced in 2004 when the rest of the subdivision was completed. The asphalt on these roads might be the original from when they were constructed in the 1990's.

In compliance with the City's purchasing requirements, the project will be utilizing an existing contract between Sparks Concrete and Volusia County as was done in Phase I. The total cost of the resurfacing in Phase II is expected to be \$206,328 as budgeted in the current fiscal year.

Staff recommends approving the contract with Sparks Concrete for the completion of the second phase of our roadway resurfacing project. If approved, the resurfacing will be completed by the end of this month.
