- 1. City of South Daytona Code of Ordinances Section 4-14. Duty to keep animal under restraint. (a)It shall be the duty of every owner of any animal, or anyone having any animal in his possession or custody, to ensure that the animal is kept under restraint to prevent the animal from leaving, while unattended, the real property limits of its owner, possessor or custodian, and that it is:(1)Securely and humanely enclosed within a house, building, fence, pen or other enclosure out of which it cannot climb, dig, jump or otherwise escape on its own volition; and such enclosures must be securely locked at any time the animal is left unattended; or(2)Securely and humanely restrained by chain, cable and trolley, or other tether of sufficient strength to prevent escape; or(3)On a leash and under the control of a competent person.
- 2. City of South Daytona Code of Ordinances Section 4-47. Required. Any person owning, keeping, harboring or having custody of any dog or cat over six (6) months of age within this city must obtain a license as herein provided.
- 3. City of South Daytona Code of Ordinances Section 4-56. Tags required. Upon acceptance of the license application and fee, the licensing authority shall issue a durable tag stamped with an identifying number and the year of issuance. Tags should be designed so that they may be conveniently fastened or riveted to the animal's collar or harness.
- 4. City of South Daytona Code of Ordinances Section 4-57. Dogs, cats to wear tags. Dogs and cats must wear identification tags at all times when off the premises of the owners.
- 5. City of South Daytona Code of Ordinances Section 4-11. Duty of all animal owners to be responsible owners. (a) It shall be the duty of every owner of any animal, or anyone having animal in his possession or custody, to take all necessary steps and precautions to prevent such animals from becoming a nuisance and to protect other persons, property and animals from injuries or damage which might result from their animals' behavior, regardless of whether such behavior is motivated by mischievousness, playfulness or ferocity. (b) In the event that the owner or keeper of any animal is a minor, the parent or guardian of such minor shall be responsible to ensure that all provisions of this section are complied with.

6. City of South Daytona Code of Ordinances Section 18-1 (e) *Vehicles considered to be illegally parked.* A motor vehicle, including cars, trucks or motorcycles, shall be considered to be illegally parked at any time that it is stopped, standing or parked.

- International Property Maintenance Code 304.12, Handrails and guards Comments: Every handrail and guard shall be firmly fastened and capable of supporting normally imposed loads and shall be maintained in good condition.
