Debris Removal and Monitoring Notice to Proceed with Crowder Gulf and Tetra Tech

In 2019, the City entered into a joint procurement agreement with the cities of Holly Hill and New Smyrna Beach for Debris Removal Services and Debris Monitoring Services with Crowder Gulf Joint Venture Inc and Tetra Tech Inc, respectively. Renewals were approved in April 2024.

In accordance with our emergency procurement procedures, staff is requesting the City Council formally approve the Notice to Proceed for the agreements. Debris collection and monitoring activities have concluded. Tetra Tech will then remain to assist the City in seeking reimbursement for our collection activities. Funds expended will be taken out of the City's Hurricane Reserve.

Building Department Reserve Fund to cover the costs of owner/builder permit fees related to Hurricane Ian (including state taxes and fees) until December 31, 2024

In order to assist residents with property restoration following the devastating effects of Hurricane Milton, all permits related to hurricane restoration will be expedited. Staff will also utilize the Building Department Reserve Fund to cover the costs of owner/builder permit fees (including state taxes and fees) for those repairs attributable to Hurricane Milton until December 31, 2024. Staff implemented this in 2022 for Hurricanes Ian and Nicole and found it very successful.

Temporary License Agreement with 2900 Ridgewood Owner, LLC for a Temporary Debris Management Site in response to Hurricane Milton

As in Hurricane Ian, the owners of 2900 S. Ridgewood Avenue (old Cemex site) generously allowed the city to use the site for debris monitoring and collection at no charge. Grinding and disposal at the Volusia County Landfill should begin shortly.

In accordance with our emergency procurement procedures, staff is requesting the City Council formally approve the Temporary License Agreement for a Temporary Debris Management Site in response to Hurricane Ian with 2900 Ridgewood Owner, LLC. It is
