Subject: Authorization to Purchase LIFEPAK 35 Cardiac Monitor

Background:

The South Daytona Fire Department is requesting authorization to purchase one (1) LIFEPAK 35 cardiac monitor with associated accessories and service coverage from Stryker Sales. This acquisition will enhance the department's advanced life support capabilities, replace aging equipment, and ensure the highest level of pre-hospital cardiac care for the community.

The proposed LIFEPAK 35 unit is equipped with multi-parameter monitoring, including 12-lead ECG, NIBP, SpO₂, EtCO₂, Wi-Fi/cellular connectivity, and CPR feedback. The package also includes multiple blood pressure cuffs (infant to XL adult), reusable sensors, battery system, printer kit, storage bag, and a one-year ProCare service plan covering parts, labor, preventative maintenance, and batteries.

The new unit will replace the current Zoll X-Series monitor, which will be traded in for a \$7,500 credit. This purchase also qualifies for a \$1,500 Early Adopter Credit Promotion.
