Subject: Community Redevelopment Area (CRA) Demolition Grant - Asbestos Removal

INTRODUCTION:

This memorandum serves to request approval for additional CRA Demolition grant funds for asbestos removal at 2919 S. Ridgewood Avenue.

BACKGROUND AND ANALYSIS:

The property located at 2919 S. Ridgewood Avenue is zoned Business General Commercial (BGC) and the Future Land Use is Mixed-Use 1. The existing single-family house and accessory structures are a non-conforming use at this .22-acre site. The property is located directly on U.S.1 and is adjacent to commercial uses, including Bellissima Salon to the north and ERGA mini-storage facility to the south.

A CRA Demolition Grant for the removal of all structures and fencing at the property located at 2919 S. Ridgewood Avenue was approved on June 8, 2021. However, upon initiation of the work, asbestos was found through out the building and roof structure. Asbestos findings are included in Attachment A – Demolition and Asbestos Contract Agreements.

Due to the high cost of the asbestos removal, the applicant is requesting additional grant funds to assist with the project.

Recommendation:

Staff recommends funding the asbestos removal grant request for up to 50% of the of the asbestos removal quote of \$7,500. The matching funds would total \$3,750. That would bring the total CRA Demolition Grant funds for both asbestos removal and demolition to \$7,337.50.

Reimbursement will be made to the applicant upon completion of all work and upon proof of payment for grant-related expenses for demolition. The site must also pass a final inspection by the Chief Building Official. To pass the final inspection, the site must be cleared of all structures, including fencing and debris, and the site must be fully sodded and/or hydroseeded.
