Re: Consideration of approving Resolution No. 2021-27, declaring the 1989 Pierce Lance Fire Truck as surplus and donating to the Flagler County School District.

In 2018, the City of South Daytona received a grant from the Department of Homeland Security, Assistance to Firefighters Grant (AFG) to purchase a 2019 Pierce Saber Custom class A pumper truck. The grant stipulated that the replaced Fire Truck (1989 Pierce Lance Fire Truck) could no longer be utilized for any kind of emergency response. Since the vehicle is in operational order and has an operational pump, I have been working with the Flagler County School District to accept the truck as a donation to use for training purposes at the Flagler County Palm Coast High School Fire Academy. The Flagler School Board accepted the donation on September 21, 2021.

The 1989 Pierce Lance Fire Truck, asset number 1052, was purchased in January of 1989. The initial cost of this 32-year-old vehicle was \$100,000 and has been fully depreciated.

Staff recommends approving Resolution No. 2021-27, declaring the 1989 Pierce Lance Fire Truck as surplus and donating it to the Flagler County School District. If approved, staff will work with the Flagler County School District to complete the transfer and the title change through the Florida Department of Highway Safety and Motor Vehicles.

RESOLUTION NO. 2021-27

A RESOLUTION OF THE CITY OF SOUTH DAYTONA, FLORIDA, DECLARING THE 1989 PIERCE LANCE FIRE TRUCK AS SURPLUS; APPROVING THE DONATION OF THE SURPLUSED TRUCK TO THE FLAGLER COUNTY SCHOOL DISTRICT AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO COMPLETE THE TRANSFER; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTING RESOLUTIONS; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the city owns a 1989 Pierce Lance Fire Truck, and;

WHEREAS, in 2018, the city received funds from the Department of Homeland Security, Assistance to Firefighters Grant (AFG) to purchase a 2019 Pierce Saber Custom class A pumper truck; and

WHEREAS, the grant stipulated that the replaced Fire Truck (1989 Pierce Lance Fire Truck) could not be utilized for any kind of Emergency response; and

WHEREAS, Fire Chief Giles worked with the Flagler County School District to accept the vehicle as a donation to be used as a training prop at the Flagler Palm Coast High School Fire Academy at their September 21, 2021, Board Meeting; and

WHEREAS, Staff recommends the donation since the 1989 Pierce Lance Fire Truck is unnecessary for its public purpose and it is in the best interest of the city to donate the truck.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA:

SECTION 1. The City Council of the City of South Daytona hereby:

- (1) determines and finds the 1989 Pierce Lance Fire Truck to be unnecessary for its public purposes; and
- (2) determines that disposal of the 1989 Pierce Lance Fire Truck is in the best interest of the public; and
- (3) authorizes staff to facilitate the donation of the 1989 Pierce Lance Fire Truck to the Flagler County School District.

SECTION 2. If any section, subsection, sentence, clause, phrase, or portion of this Resolution, or application hereof, is for any reason held invalid or unconstitutional by any Court, such portion

or application shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions or application hereof.

SECTION 3. That all resolutions made in conflict with this Resolution are hereby repealed.

SECTION 4. Effective Date. This resolution shall take effect immediately upon its passage and adoption.

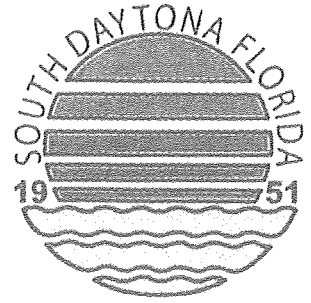

IMPORTANT INFORMATION

SECTION 320.0605, Florida Statutes, requires this registration certificate or an official copy or a true copy of a rental or lease agreement issued for the motor vehicle described be in possession of the operator or carried in the vehicle while the vehicle is being used or operated on the highways or streets of this state.

SECTION 316.613, Florida Statutes, requires every operator of a motor vehicle while transporting a child in a passenger car, van or pickup truck registered in this state and operated on the highways of this state, shall, if the child is 5 years of age or younger, provide for protection of the child by properly using a crash-tested, federally approved child restraint device. For children aged through 3 years, such restraint device must be a separate carrier or a vehicle manufacturer's integrated child seat, for children aged 4 through 5 years, a separate carrier or seat belt may be used.

SECTION 627.733, Florida Statutes, requires mandatory Florida No-Fault Insurance to be maintained continuously throughout the entire registration period; failure to maintain the required coverage could result in suspension of your driver license and registration.

IMPORTANT INFORMATION

1. The Florida license plate must remain with the registrant upon sale of vehicle.
2. The registration must be delivered to a Tax Collector or Tag Agent for transfer to a replacement vehicle.
3. Your registration must be updated to your new address within 20 days of moving.
4. Registration renewals are the responsibility of the registrant and shall occur during the 30-day period prior to the expiration date shown on this registration. Renewal notices are provided as a courtesy and are not required for renewal purposes.

VR - CITY VEHICLES

FIRE ENGINE DONATION

A. Any fire engine donated by ***The South Daytona Fire Department*** to Flagler County School District (FCSD) shall be considered only a training prop for the students, since it is not recognized by Florida Bureau of Standards and Training as a designated training engine at the ***Flagler*** County Fire Training Center.

B. ***Flagler County*** agrees to inspect, and pump test the engine annually and provide FCSD with the results of the inspection and test.

C. Maintenance of the fire engine, to include the motor, power train, chassis, and body, power take off (PTO) pump, pump housing and valves, will be the responsibility of the FCSD.

D. If at any time, FCSD is not able to maintain the fire engine to minimum standards to pass the ***pump test***, annual inspections, then FCSD agrees to exercise one of the following two options:

i. FCSD may request that ***Flagler County*** make the necessary repairs, but FCSD acknowledges that ***Flagler County*** has no obligation to do so, and ***Flagler County*** will decide whether to make the repairs at its sole discretion; or

ii. FCSD may ~~return~~_{transfer} the fire engine to ***Flagler County***.

The City of South Daytona or the South Daytona Fire Department relinquishes all responsibilities, liabilities and ownership of said fire truck. It shall also be understood that if in the future said fire truck becomes unusable by Flagler County, they can decide on the disposal method. Said fire truck shall never be used to run emergency responses. This requirement has been set forth by FEMA to South Daytona when said fire truck was relaced by a vehicle acquisition grant.
