Beverly Abrahamson, Code Compliance Officer, presented the case and requested that the respondent be found in violation with authorization to abate.

Respondent Carey Cyr was in attendance. She explained the case and the circumstances. She noted that a permit was issued on June 7, 2021, and new, permanent metal sides will be installed after materials arrive. She did note her concern in getting materials in a timely manner and requested a 90-day extension.

Special Master Branz found the respondent in violation and ordered a compliance date of July 12, 2021 with authorization to abate with a \$125 administrative fee plus any costs incurred during the abatement process.

Special Master Branz signed the Findings of Fact with Abatement, Conclusion of Law and Order.

Bret Steele, Code Compliance Officer, presented the case and requested that the respondent be found in violation with authorization to abate.

Respondent was not in attendance.

Special Master Branz found the respondent in violation and ordered a compliance date of July 15, 2021 and failure to comply will result in a fine of \$250 per day until the violations are corrected as well as authorization for the city to abate with a \$125 administrative fee plus any costs incurred during the abatement process.

Special Master Branz signed the Findings of Fact with Abatement, Conclusion of Law and Order.

Beverly Abrahamson, Code Compliance Officer, presented the case and requested that the respondent be found in violation with authorization to abate.

Special Master Quarles had continued the case until the June hearing, for the attorney to be present and explain the time needed to correct the violation.

Respondent representative, Jay Martinez (We Work You Play Handyman, 595 Brook Circle, South Daytona) and Public Adjuster Bruce Anderson (Five Star Claims Adjusting, 351 Myakka Street N.E., Palm Bay) was in attendance and represented the homeowner of 700 Ridge Blvd. They explained the delay was due to an insurance claim. They were unsure of the number of days needed to correct the violation and obtain permits.

Special Master Branz found the respondent in violation and ordered a compliance date of August 6, 2021 and failure to comply will result in a fine of \$250 per day until the violations are corrected. If the respondent fails to comply by August 6, 2021, authorization to abate with a \$125 administrative fee plus any costs incurred during the abatement process. He stated that we will place this case on the August 12, 2021, Special Master Hearing agenda.

Special Master Branz signed the Findings of Fact with Abatement, Conclusion of Law and Order.
