### MEMORANDUM

**Re:** **Consideration of Resolution 2022-13.** For a cost reimbursement grant for Harborside Stormwater Pond Stationary Pump with the Florida Department of Environment Protection (FDEP) and authorizing the Mayor and City Manager to execute the Grant Agreement and associated documents related to the project.

For the 2022/2023 State Legislative Session, City Lobbyist, Doug Bell presented an Appropriations Request for South Daytona's Harborside Stormwater Pond Stationary Pump. Senator Tom Wright and Representative Elizabeth A. Fetterhoff sponsored the City's request for the funding. In June, Governor DeSantis approved the 2022-2023 State Budget which included \$100,000 for our Harborside Stormwater Pond Stationary Pump.

The Harborside subdivision has two stormwater ponds to alleviate flooding. The two stormwater ponds are tied together with a pipe that carries the overflow to Reed Canal. When the water in Reed Canal is high, there is no place for the overflow from the Harborside subdivision to go and it backs up into their streets. To alleviate this situation, the city places a portable stormwater pump at the location each year which takes the overflow and forces it into Reed Canal.

This project involves the installation of a permanent in-ground pump at the subdivision designed to handle the overflow following a severe rain event. The permanent pump will allow for the portable pump normally stationed here to be utilized in other vital areas. The stationary, permanent pump will provide a safer, more reliable system for flood protection for our residents and assist our overall goal of resiliency.

The total cost of the proposed project is approximately \$350,000. This grant will account for \$100,000 of that cost thereby reducing the city's financial responsibility.

Attached to this memorandum is Resolution No. 2022-13 which approves the cost reimbursement grant for Harborside Stormwater Pond Stationary Pump with the Florida Department of Environment Protection (FDEP) and authorizes the Mayor and City Manager to execute the Grant Agreement and associated documents related to the project.

If approved, the city's contribution for the project (\$250,000) will be included in next fiscal year's budget (FY 2022-23). Staff anticipates it will take six months to acquire the stormwater pump and three months to install it. We will make every effort to get the pump operational before the 2023 hurricane season.

## **RESOLUTION NO. 2022-13**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA, APPROVING THE COST REIMBURSEMENT GRANT FOR HARBORSIDE STORMWATER POND STATIONARY PUMP WITH THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION (FDEP); AUTHORIZING THE MAYOR AND CITY MANAGER TO EXECUTE THE GRANT AGREEMENT AND ASSOCIATED DOCUMENTS RELATED TO THE PROJECT; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, in June 2022, Governor DeSantis approved the 2022-2023 State Budget with included \$100,000 appropriation for the City of South Daytona's Harborside Stormwater Pond Stationary Pump; and

**WHEREAS**, Senator Tom Wright and Representative Elizabeth A. Fetterhoff supported the City's request in the Appropriation for the funding for the needed Harborside Stormwater Pond Stationary Pump throughout the 2022 Legislative Session; and

**WHEREAS**, the stationary pump will provide a safer, more reliable system for flood protection services for the residents of the City of South Daytona; and

**WHEREAS**, the City Council expresses sincere gratitude to Governor Ron DeSantis, Senator Tom Wright and Representative Elizabeth A. Fetterhoff for their support for this important flood protection project; and

**WHEREAS**, the \$100,000 appropriation was placed in the Florida Department of Environment Protection (FDEP) budget and will be provided to South Daytona through a Reimbursement Grant; and

**WHEREAS**, the City Council of the South Daytona desires to proceed with the Reimbursement Grant.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA:**

**Section 1.** The Mayor and City Manager of the City of South Daytona are hereby authorized to execute agreements or contracts necessary to implement this Resolution.

**Section 2.** The City Manager is responsible for overseeing the grant agreement with the Department of Environmental Protection (FDEP) for the South Daytona Harborside Stormwater Pond Stationary Pump Project.

**Section 3.** That this Resolution shall become effective immediately upon its adoption.
