The 2022 General Election was scheduled for August 23, 2022 pursuant to and in accordance with the Florida Election Code and the South Daytona City Charter. After the qualifying period ended at noon on Friday, June 17, 2022, Doug Quartier Seat 2 and Lisa O'Neal Seat 3 were declared unopposed per the South Daytona City Charter Section 6.05 Election Procedure, (b) Single candidates.

# Section 6.05. Election procedure.

(b) Single candidates. In the event not more than one (1) person qualifies as a candidate, either for ballot listing or write-in, for a seat on the city council to be filled, that seat shall not be listed on the regular city election ballot, and the person who qualified as the only candidate for the seat shall be declared elected.

Staff recommends the City Council approve Resolution No. 2022-28 declaring Doug Quartier, elected to Seat 2 and Lisa O'Neal, elected to Seat 3 for a four-year term (until 2026).
