#### **Volusia Growth Management Commission (VGMC) Reappointment:**

Attached for your review and consideration is an application of a resident interested in continuing to serve on the Volusia Growth Management Commission (VGMC). Currently, the Commission has one appointed Representative from the City of South Daytona. Mrs. Christy Gillis represents the City and is currently on the budget committee and her present four-year term is scheduled to expire on June 30, 2023. However, the City has been contacted by the VGMC and they are requesting that the City re-appoint Mrs. Gillis, if she is still interested in serving. Mrs. Gillis has represented the City of South Daytona on the Commission since February 2016, currently serves as the Secretary of the Commission, and Chair of the Commission's Budget Committee, and is interested in continuing to serve the City of South Daytona on this Board.

The City has not received any additional applications from interested residents willing to fill this appointed position.

#### **Citizens' Advisory Committee (CAC) Appointment**

Mr. Jack Delaney has served as the City's Citizens' Advisory Committee Member for the River to Sea Transportation Planning Organization (R2CTPO) since April 2016. He has recently requested the City find a replacement. Ms. Kathryn Meagher has volunteered to fulfill this role.

The Citizens' Advisory Committee (CAC) is responsible for providing citizen input and recommendations to the TPO Board concerning transportation planning and programming; for review of all transportation studies, reports, plans and/or programs; and for making recommendations to the TPO Board. Subcommittees, Task Forces and Working Groups are created by the CAC as necessary to investigate and report on specific subject areas of interest to the CAC. The CAC meets in the Airline Room at the Daytona Beach International Airport on the third Tuesday of each month at 1:15 p.m.

The City has not received any additional applications from interested residents willing to fill this appointed position. Ms. Meagher's application is attached to this memorandum for review.
