Re: Consideration of approving Resolution No. 2023-16 accepting Underground

Utility Easements on South Ridgewood Avenue for future phases of the US 1

Streetscape Project. First and only reading.

Date: July 7, 2023

The US1 Streetscape Project began in 2009. A key component of that project included the burial of all overhead utilities along South Ridgewood Avenue (US 1) from Beville Road to McDonald Street. The FY 2022/2023 budget included \$700,000 to continue the overhead utility burial project from McDonald Street to Ridge Boulevard with additional funding planned for FY 2024, 2025 and 2026. The overhead utility burial portion of the streetscape project should be complete in 2026. Once utilities are buried, then the proposed decorative sidewalk, landscaping and streetlighting can be installed by utilizing possible grant opportunities to complete the overall streetscape project on US 1.

A 10-foot easement is required from each property owner along the corridor in order to bury the overhead utility lines, provide additional landscaping, install decorative light poles, install sidewalk improvements as well as other amenities. In 2005, the City secured easements from most of the property owners. Staff requests the Council approve the easements previously acquired and allow the City Manager to execute any remaining easements needed for the project.

A list of the acquired Easements along US 1 is attached to the Resolution.

Staff requests the City Council approve Resolution No. 2023-16 to accept the Underground Utility Easements on South Ridgewood Avenue for future phases of the US 1 Streetscape Project and authorize the City Manager to execute any remaining easements needing to be acquired to facilitate the project.

RESOLUTION NO. 2023-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA, ACCEPTING UNDERGROUND UTILITY EASEMENTS ON SOUTH RIDGEWOOD AVENUE FOR FUTURE PHASES OF THE US 1 STREETSCAPE PROJECT; PROVIDING FOR SEVERABILITY, CONFLICTS, AND AN EFFECTIVE DATE.

WHEREAS, at the request of the City of South Daytona, a number of property owners along US 1 have executed and delivered to the City certain Utility Easements, which have been recorded as specified in Exhibit "A", across a portion of their respective properties; and

WHEREAS, the City of South Daytona is presently finalizing the execution and delivery of Utility Easements from additional property owners along US 1; and

WHEREAS, such Utility Easements are required to allow the City to underground utilities along US 1 as part of future phases of our US 1 Streetscape Project; and

WHEREAS, the City Council has determined that it is in the best interest of the City to formally accept the Right-of-Way Dedications and Utility Easements previously delivered to the City, and to authorize the acceptance of future Utility Easements delivered to the City by property owners at the request of the City for future phases of the US 1 Streetscape Project.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA:

<u>Section 1.</u> The City of South Daytona hereby accepts the Utility Easements referenced in Exhibit "A" hereto.

<u>Section 2.</u> The City of South Daytona hereby authorizes the acceptance of all future Utility Easements delivered to the City by property owners at the request of the City for future phases

of the US 1 Streetscape Project, and the City Manager is authorized to execute appropriate instruments to memorialize such acceptance.

<u>Section 3.</u> If any section, subsection, sentence, clause, phrase, or portion of this Resolution, or application hereof, is for any reason held invalid or unconstitutional by any Court, such portion or application shall be deemed a separate, distinct, and independent provision, and such holding shall not the validity of the remaining portions or application hereof.

Section 4. All resolutions made in conflict with this Resolution are hereby repealed.

Section 5. This Resolution shall become effective immediately upon its adoption.
