Item 4. CRAG Resolution No. 2023-01. A Resolution of the City of South Daytona, Florida Community Redevelopment Agency (CRAG) adopting the Redevelopment Trust Fund Budget for the Fiscal Year beginning October 1, 2023 and ending September 30, 2024; prescribing the net sources of revenue in the estimated amount of \$3,478,697; setting forth operating expenditures and transfers in the amount of \$3,478,697; providing for severance; providing for conflicting resolutions; and providing an effective date. First and only Reading. Public Hearing.

City Attorney Vose read the title of C.R.A.G Resolution 2023-01.

City Manager Gillis explained the area which encompasses the Community Redevelopment Area. He said this area has higher development standards and the tax money received from property taxes must be utilized within it. He noted the CRA will sunset in 2026. He discussed the 2023-2024 proposed budget which includes US 1 streetscape improvements, undergrounding the utility lines, installation of the entryway features, as well as a wall on Segrave Street in front of the Public Works facility.

He concluded with a staff recommendation of approval of the FY 23/24 Redevelopment Trust Fund Budget.

Mayor Hall opened the Public Hearing. No comments were received. Mayor Hall closed the public hearing.

Member Eric Sander clarified the budget is for 2023/2024 noting a scrivener's error on the chart within the agenda packet.
