FLORIDA COMMUNITY REDEVELOPMENT AGENCY (CRAG) ADOPTING THE REDEVELOPMENT TRUST FUND **BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1,** 2020 AND ENDING SEPTEMBER 30, 2021; PRESCRIBING THE NET SOURCES OF REVENUE IN THE ESTIMATED AMOUNT OF \$1.940.249: SETTING FORTH **OPERATING** EXPENDITURES AND TRANSFERS IN THE AMOUNT OF \$1,940,249; PROVIDING FOR SEVERANCE; PROVIDING FOR CONFLICTING RESOLUTIONS: AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Finance Director has prepared a budget for the Fiscal Year 2020-2021 Redevelopment Trust Fund budget and has submitted the same to the CRAG; and

WHEREAS, the proposed budget sets forth in detail all information required in accordance with Florida Statute, Chapter 189.016, and has been posted on the City's website at least two days prior to adoption; and

WHEREAS, the CRAG has made a study of the recommended budget and has made any desired adjustments; and

WHEREAS, the budget is available for public inspection in the Office of the City Clerk and on the Community Redevelopment Area (CRA) webpage on the City website.

<u>Section 2</u>. The Fiscal Year 2020-2021 Redevelopment Trust Fund budget setting forth both revenues and expenditures is hereby adopted and made part of this Resolution.

<u>Section 3</u>. The Redevelopment Trust Fund budget as adopted in the preceding section shall govern expenditures of the Community Redevelopment Agency for the fiscal year commencing October 1, 2020 and ending September 30, 2021 upon final adoption.

Section 4. *Repealer*. All prior resolutions, if any, which conflict with this Resolution are hereby repealed.

<u>Section 5</u>. Severability. If any section, subsection, sentence, clause, phrase or portion of this resolution, or application hereof, is for any reason held invalid or unconstitutional by any Court, such portion or application shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions or application hereof.

Section 6. Effective Date. This Resolution shall become effective immediately upon its adoption.
