MESSAGE FROM THE MAYOR



2022!!! The last two years have been trying and hard on many of our residents, I know we have all faced some type of struggle, and yet we have made our way to this new year.

2021 was full of new development with construction underway and interest in future development over the next few years. The Enclave was

completed in March 2021 and is at 98% occupancy. Some highlights of upcoming development include the Silvestri Investments townhomes and condominium project located at 3151 S. Ridgewood Avenue which is expected to begin construction by early spring of 2022. This project will include 17, 2-story townhomes, clubhouse, and 37 boat slips. In May 2021, the City Council approved a 330-unit luxury apartment complex with a first-floor river view restaurant and 145 boat slips that will be constructed at 2941 S. Ridgewood Avenue. Also, in the review process is a multi-family project that may be developed at the old CEMEX plant at 2900 S. Ridgewood. This is especially exciting as the dilapidated and unsightly cement plant equipment will be demolished to make way for a beautiful residential development. This and other development in the City promises to bring new commercial and retail business opportunities along U.S.1.

This fall was full of fun events hosted by our Parks and Recreation Department including the Annual Blaine O'Neal Golf Tournament that raises money annually for our Community Trust. The Trust provides funds for low-income homeowners with health and safety issues on the exterior of their home, and also awards college and technical school scholarships annually.

Staff from the Fire and Police Departments continue to obtain grants, for equipment to keep employees safe and healthy. The City will also be receiving Federal Recovery Act Funds under the American Rescue Plan Act to invest in the rehabilitation of our aging water and sewer infrastructure. Improvements will be made to four lift stations, sewer pipe lining and replacement, potable water main replacement, and modernization of the water meter system.

Other family friendly events included Movie Night, Light the Night, Drive-Thru Boo, and the re-imagined BBQ and Bluegrass Fest was a tremendous success with almost 3,000 participants. The BBQ fest had teams from around the state compete in a Florida BBQ Association sanctioned competition. The event was filled with activities for the kids, food and merchant vendors and music from several of the top Bluegrass bands.

Why "Flushable" Wipes Are Unflushable

"FLUSHABLE" wipes, such as make-up removal wipes, cleaning wipes and baby wipes should not be flushed down the toilet, even if their products' packaging states that they are flushable. As convenient as flushing wipes may sound, the claims on the product packaging are misleading. Wipes do not break down in the wastewater treatment process the same way that toilet paper does, creating clogs in pipes and sewers.

As an incentive to buy wipes and personal hygiene products, some manufacturers state that their products are OK to flush on the package. However, a majority of municipalities agree that these wipes are not safe to flush because they are:

- Buoyant
- · Unable to break down into small pieces quickly
- Contain plastic, regenerated cellulose or materials that do not readily degrade in a range of natural environments

These disposable wipes are one of the main culprits to cause millions of dollars in wastewater infrastructure damages across the United States.

Ignore the flushable information on your wipes' packaging when they state that wipes are safe to flush. Wipes are not safe to flush. ALL WIPES, including cleaning wipes, baby wipes, adult personal hygiene wipes, facial wipes and make-up removal wipes should be disposed of in the garbage.

Help Us Stop Illegal Dumping

Illegal dumping is the deliberate disposal of waste materials onto public or private land. Illegal dumping causes:

- Rising costs for continual clearing of illegally dumped waste to the City
- Environmental damage including destruction of vegetation and leaching of hazardous materials into the soil and waterways
- · Decreasing property and community value
- Hazards and risks to people and animals, particularly when waste includes sharp objects, asbestos and glass.

Your City, in partnership with Waste Pro, is on the watch for illegal dumping activity. The City provides services for solid waste and recycling. It is your responsibility to appropriately dispose of hard waste (large items) that cannot go in your regular waste collection.

You can help by contacting Public Works at 322-3080 for details regarding disposal of your waste and collection of your recycling. Being an informed community member is a positive step towards reducing illegal dumping.

Citizens Patrol

Happy 2022 to my fellow South Daytonans.

It's the middle of the night and you are awaken by your smoke detector beeping. You get out of bed and get your family out of the house. You call 9-1-1 and request the Fire Department respond.

Now they have to find you.

When any first responder responds to your house in the dark, it really helps them if your address numbers are clearly visible. Having spent many years of my life looking for an address in the dark, I know how frustrating it can be.

First, use LARGE numbers that are painted in bright colors that contrast the color of your home. You want these numbers to stand out. Mount the numbers on the front of the house, by or above the garage. If the numbers are mounted by, of near, a light you keep on at night, even better.

If you have a mailbox mounted by the edge of the street, buy the reflective numbers (available at most stores that have a hardware department) and mount the numbers on both sides of the mailbox. These numbers really jump out when headlights hit them at night.

When first responders are rushing to help you, help them by making it easier to find you. The UPS, FEDEX and Amazon delivery people will appreciate the easy to read numbers too. -Captain James Crabtree

CRA

Have you noticed City workers with bright orange shirts with the letters CRA on them working along the South Ridgewood Avenue? If so, you may want to know what CRA means?

CRA is the acronym for Community Redevelopment Area/Agency.

A Community Redevelopment Agency (CRA) refers to a public entity created by a city or county to implement the community **redevelopment** activities outlined under the Community Redevelopment Act which was enacted in 1969 (Chapter 163, Part III, Florida Statutes). The CRA is established by the local government and functions within that local government. The City Council sits as the Community Redevelopment Agency and makes all final decisions on actions or expenditures within the CRA (area). The purpose of a CRA is **redevelopment and revitalization** of a public area, and the preservation of a community's history. **It is about building cohesiveness within our community**.



Meet our new CRA Maintenance Workers, Matthew Shire and Steven Durrance, who joined our City in November.

Matthew and Steven both bring commitment to the beautification of our Community Redevelopment Area and the U.S.1 commercial corridor.

Matthew and Steven will be seen working along South Ridgewood Avenue in our ongoing efforts of beautifying the corridor by mowing, trimming, edging, and debris pickup. They will also be renewing and refreshing the U.S.1 Streetscape landscaping from Beville Road to McDonald Road and the medians in the CRA.

The City of South Daytona Community Redevelopment Area (CRA)

South Daytona CRA The CRA was established in 1996 to eliminate slum and blight. The CRA Redevelopment Master Plan was approved in 1997 to establish programs to realize goals and objectives to improve this area of the City.

South Daytona CRA Boundaries The CRA boundaries are highlighted in green on the map. The CRA represents about one-third of the total City area and runs the entire length of the City from Beville Road to the South City limits and from the railroad track to the Halifax River.

South Daytona CRA Redevelopment Master Plan Focuses on the Future Land Use Plan, Amenity Programs, Private Catalyst and Public Improvement Programs. Planned improvements completed, underway, ongoing, or planned include: U.S.1 Streetscape public improvements, community policing, code enforcement, blight removal, redevelopment of U.S.1 corridor, and Sunshine Park pedestrian area planning.
