

Re: First Public Hearing - A Resolution of the City Council of the City of South Daytona Adopting the Tentative Millage Rate for the Fiscal Year 2022-2023

Date: August 24, 2022

- **Issue:** The Truth in Millage (TRIM) process informs taxpayers and the public about the legislative process by which local taxing authorities determine ad valorem (property) taxes. When levying a millage, taxing authorities must follow chapter 200 of the Florida Statutes which govern TRIM. State laws require that two formal public hearings be held in September to adopt the millage rate for the upcoming fiscal year, 2022-2023. At the first public hearing, the City will adopt a tentative millage rate and set a date and time for the final public hearing.
- **Solution:** Resolution No. 2022-20, attached, adopts the tentative millage rate at 7.75 and sets the final public hearing for September 27, 2022, at 6:00 pm. The proposed budget for fiscal year 2022-2023 is based on this millage rate which is 6.92% higher than the rolled-back rate. The wording of the attached resolution is consistent with the 2022 TRIM Compliance Workbook provided by the Florida Department of Revenue.
- **Recommendation:** Staff requests council adopt the tentative millage rate and set the final public hearing date for September 27, 2022, at 6:00 pm.
- **Result:** The City will remain in compliance with TRIM requirements. According to Florida law, failure to meet TRIM requirements will result in loss of revenue sharing for the taxing authority. The proposed millage rate will result in an increase of approximately \$2 per month for the average value of a house in South Daytona (\$100,000 taxable value with the save our homes provision). The property tax paid to South Daytona is only about 38% of a homeowner's tax bill. The School Board is about 27% of your tax bill while Volusia County accounts for about 28% as seen in the chart on the following page. Also shown is a composite tax bill for an average house in South Daytona. Notice that the total tax bill will decrease if the other agencies keep their preliminary millage rates.

RESOLUTION NO. 2022-20

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA, ADOPTING THE TENTATIVE MILLAGE RATE FOR THE LEVY OF AD VALOREM TAXATION FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2022 AND ENDING SEPTEMBER 30, 2023; SPECIFYING THE DATE, TIME, AND PLACE OF THE SECOND AND FINAL PUBLIC HEARING TO ADOPT A FINAL MILLAGE RATE; AND PROVIDING FOR SEVERABILITY AND AN EFFECTIVE DATE.

WHEREAS, on July 26, 2022, the City Council established a proposed millage rate, computed a rolled-back rate, and established a date, time, and place for a public hearing to consider the proposed millage rate and tentative budget for Fiscal Year 2022-2023; and

WHEREAS, pursuant to Section 200.065, Florida Statutes, a public hearing on the proposed millage rate has been conducted by the City Council on September 12, 2022, at 6:00 pm at South Daytona City Hall in the City Council Chambers, 1672 South Ridgewood Avenue, South Daytona, Florida; and

WHEREAS, a second and final public hearing to adopt a final millage rate will be conducted on September 27, 2022 at 6:00 pm at South Daytona City Hall in the City Council Chambers, 1672 South Ridgewood Avenue, South Daytona, Florida; and

WHEREAS, the gross taxable value for operating purposes, not exempt from taxation, has been certified by the Volusia County Property Appraiser to the City of South Daytona as \$827,265,036.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA OF VOLUSIA COUNTY, FLORIDA:

SECTION 1. The FY 2022-23 operating millage rate is 7.75 mills, which is greater than the rolled-back rate of 7.2481 mills by 6.92%.

SECTION 2. A second and final public hearing to adopt a final millage rate will be conducted on September 27, 2022 at 6:00 pm at South Daytona City Hall in the City Council Chambers, 1672 South Ridgewood Avenue, South Daytona, Florida.

SECTION 3. SEVERABILITY. If any section subsection or portion of this Resolution proves to be invalid, unlawful, or unconstitutional, it shall not be held to invalidate or impair the validity, force, or effect of any other section or part of this Resolution.

SECTION 4. EFFECTIVE DATE. This Resolution shall take effect immediately upon its adoption by the City Council.
