The city currently has an agreement for Continuing Services with Universal Engineering Sciences for Building Inspections, Plan Review and Building Official Services. Staff has supplemented the services of Universal Engineering Sciences with Bureau Veritas (John Boden) over the last year to save on costs. With the resignation of our Chief Building Official in December, staff requests the City Council enter into an agreement with Bureau Veritas North America Inc for supplemental Building Official Services.

The City of South Daytona Purchasing Policy allows the Council to waive the written quote and formal bidding requirements where solicitation of bids is deemed not to be in the best interest of the city taking into consideration cost, delivery time, prior dealings with the vendor or product, consistency of product use, compatibility of product with existing equipment and such other considerations as deemed appropriate by the city council.

John Boden with Bureau Veritas has performed inspections and permit reviews for the city over the past three months. His services were necessary to allow the Chief Building Official more time to perform office and data entry duties while our permit technician was out on maternity leave. Now that our Chief Building Official has resigned, a seamless choice would be to allow Mr. Boden to continue providing inspection and permit review services in the interim until a new building official is hired.

By having agreements with multiple firms who can provide services for Plan Review, Inspections and Building Official Services, staff can provide the highest quality of services to our residents. Staff's goal is to provide quality, timely and friendly services especially in Permitting and Development.
