Re: Parks & Recreation ADA Alternate Board Member Appointments

The merger of the Consolidated Parks and Recreation Board with the Americans with Disabilities Act (ADA) Advisory Committee to form the Parks, Recreation and ADA Advisory Board was approved by City Council at its June meeting.
