a) **ORDINANCE NO. 17-03**

AN ORDINANCE OF THE CITY OF SOUTH DAYTONA, FLORIDA, AMENDING THE CITY'S LAND DEVELOPMENT REGULATION CODE BY CREATING SECTION 5.7 (C) (20) TO ALLOW SIGN MANUFACTURING AS A SPECIAL EXCEPTION USE IN BUSINESS GENERAL COMMERCIAL ZONING DISTRICTS; ESTABLISHING RULES AND CONDITIONS FOR SIGN MANUFACTURING AS A SPECIAL EXCEPTION; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTING ORDINANCES; AND PROVIDING AN EFFECTIVE DATE. **Second Reading. Public Hearing. Passed first reading on May 9, 2017.**

b) **ORDINANCE NO. 17-05**

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SOUTH DAYTONA, FLORIDA REPEALING SECTION 2-150 (ADDITIONAL REGULATIONS AND PROCEDURES) OF THE CODE OF ORDINANCES AND ADOPTING A NEW SECTION 2-150 (ACQUISITION, SALE AND LEASE OF REAL PROPERTY) ADOPTING PROCEDURES FOR THE ACQUISITION OF REAL PROPERTY, AND THE SALE AND LEASE OF CITY PROPERTY; PROVIDING FOR SEVERABILITY; PROVIDING FOR CONFLICTING ORDINANCES; AND PROVIDING AN EFFECTIVE DATE. **Second Reading. CITY MANAGER TO EXECUTE SAID AGREEMENT; PROVIDING FOR REPEAL OF RESOLUTIONS IN CONFLICT HEREWITH; PROVIDING FOR SEVERABILITY; PROVIDING AN EFFECTIVE DATE. **First and only Reading.**
