A RESOLUTION OF THE CITY OF SOUTH DAYTONA, FLORIDA, ADOPTING A TENTATIVE MILLAGE RATE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018 AND ENDING SEPTEMBER 30, 2019 AND PROVIDING FOR AN EFFECTIVE DATE. **First and only reading. Public Hearing.**
