The fire department was awarded a FEMA Assistance to Firefighter Grant in the amount of \$49,500 for the purchase and installation of a vehicle exhaust extraction system for fire station 98. The city's share of this grant will be \$2,357.14. This new system will be replacing an outdated one that was installed in 2004.

Vehicle exhaust extraction systems are designed to attach directly to the exhausts of vehicles using large hoses. The exhausts that are emitted upon start up are then moved through a series of filters and then expelled to the outside of the building. This type of system is one of many tools/methods we use in our effort to reduce the exposure of our firefighters to various carcinogen sources at the station or on emergency scenes. Our department has several standard operating procedures that address firefighter health and safety such as on scene and station gear decontamination, in station contamination prevention and spare firefighting gear availability. This new exhaust extraction system will add to our overall effort in reducing these types of contaminants to our employees.

Staff requests council accept the FEMA Assistance to Firefighter Grant in the amount of \$49,500 for the purchase and installation of a vehicle exhaust extraction system for Fire Station 98.
