Debris Hauling and Disposal Contracts with Crowder Gulf, Ceres Environmental Services, and Philips & Jordan with a 2.8% increase request as allowed in the

current contract.

Date: April 16, 2025

In 2019, the City partnered with Holly Hill and New Smyrna Beach on an RFP for Emergency Debris Hauling and Disposal services. The resulting contracts were awarded with an initial five (5) year term and included five (5) one-year renewal options. The original contract term expired in June 2024, and in April 2024, the City Council approved the first one-year renewal.

As we prepare for the second one-year renewal term, extending the agreement through June 10, 2026, City staff have reached out to the awarded vendors for Emergency Debris Hauling and Disposal. In light of increased operational costs and inflationary impacts over the past several years, all three vendors requested a 2.8% adjustment in pricing for this upcoming renewal term. Price adjustments were a part of the original contract as it had the potential to span over a ten-year period. As a result, staff and the participating cities in the contract do not believe that the 2.8% price adjustment being requested is unreasonable.

In the event of a natural disaster, having multiple debris hauling companies ensures that there are enough resources available to quickly and effectively clean up debris and restore normalcy to the City. In 2022, the City utilized the services of Crowder Gulf while Holly Hill utilized Philips & Jordan. These two companies did an excellent job in our respective cities as compared to relying on a sole source to complete the cleanup in both municipalities.

Staff recommends the City Council approve the second, one (1) year extension of the Emergency Debris Hauling and Disposal Contracts with Crowder Gulf, Ceres Environmental Services, and Philips & Jordan with a 2.8% increase as requested. Holly Hill and New Smyrna Beach will be seeking the same approval with their legislative bodies in regards to the 2.8% price increase for uniformity.

WHEREAS, the City accepted the qualifications of Crowder Gulf Joint Venture, Inc.; and

WHEREAS, the parties desire to enter into the second of five, one (1) year optional renewals of the contract Pursuant to the RFP 19-PW-16

NOW, THEREFORE, THE CITY AND CROWDER GULF JOINT VENTURE, Inc., AGREE AS FOLLOWS:

- 1. The City and Crowder Gulf Joint Venture, Inc., agree to all the terms and conditions as stated and contained in the Emergency Debris Hauling & Disposal Agreement, RFP 19-PW-16, including, any/all Attachments, Addenda, and the firm's Request for Proposals response submitted, each being by reference incorporated herein. The respective rights and obligations of the parties shall be determined in accordance with the City's RFP, the RFP Response of the firm, and Florida law.
- 2. According to the U.S. Department of Labor, Bureau of Labor Statistics Consumer Price Index over the last twelve (12) months, the all items index has increased three percent (2.8%). At this time CrowderGulf is requesting a price increase of three percent (2.8%).
- 3. The term of this contract renewal agreement shall commence upon the final signature on this document, <u>June 11, 2025</u>, and is for a one-year renewal through <u>June 11, 2026</u>.






Consumer Price Index, South Region — January 2025

Regional prices increased 0.6 percent in January and 2.8 percent over the year

The Consumer Price Index for All Urban Consumers (CPI-U) in the South region increased 0.6 percent in January, the U.S. Bureau of Labor Statistics reported today. The index for all items less food and energy also increased 0.6 percent over the month. The energy index rose 1.9 percent in January and the food index rose 0.3 percent over the same period. (Data in this report are not seasonally adjusted. Accordingly, month-to-month changes may reflect the impact of seasonal influences.)

The South all items CPI-U rose 2.8 percent for the 12 months ending in January, as it did in December. The index for all items less food and energy rose 3.1 percent over the last 12 months. The food index increased 2.6 percent for the 12 months ending in January. The energy index rose 0.7 percent over the last year.

The index for food increased 0.3 percent in January, as it did in December. The index for food at home (grocery store purchases) rose 0.5 percent, with higher prices in 5 of the 6 major grocery store food groups. The index for food away from home (restaurant, cafeteria, and vending purchases) was little changed in January, up 0.1 percent.

The index for food rose 2.6 percent over the last 12 months. The food away from home index rose 3.2 percent over the last year. The food at home index increased 2.2 percent over the same period, as each of the six major grocery store food groups increased over the last year. Within the food at home category, the index for meats, poultry, fish, and eggs increased 6.2 percent over the last 12 months.

Energy

The energy index increased 1.9 percent in January, after declining 0.4 percent in December. The gasoline index increased 2.5 percent over the month. The electricity index rose 1.0 percent over the month and the index for natural gas rose 2.3 percent over the same period.

The energy index rose 0.7 percent over the past 12 months. The index for electricity increased 1.1 percent over the last year and the index for natural gas rose 5.6 percent over the same period. The gasoline index was little changed over this 12-month span, up 0.1 percent.

All items less food and energy

The index for all items less food and energy rose 0.6 percent in January. The shelter index increased 0.5 percent over the month, after increasing 0.2 percent in each of the previous two months. The index for owners' equivalent rent rose 0.3 percent in January, as did the index for rent. Recreation (+1.4 percent) was also an index with a notable increase in January.

The index for all items less food and energy rose 3.1 percent over the past 12 months. The shelter index (+4.4 percent) was the largest contributor to the total 12-month increase in the all items less food and energy index. The index for owners' equivalent rent also increased 4.4 percent over the last year. The index for rent increased 3.6 percent over this 12-month span.

The Consumer Price Index for February 2025 is scheduled to be released on Wednesday, March 12, 2025, at 8:30 a.m. (ET).

Technical Note

The <u>Consumer Price Index</u> (CPI) is a measure of the average change in prices over time in a fixed market basket of goods and services. The Consumer Price Index for the **South region** is published monthly. The set of components and sub-aggregates published for regional and metropolitan indexes is more limited than at the U.S. city average level; these indexes are byproducts of the national CPI program.

Percent changes for all-items data previously found in Table A of this release can be accessed in Chart 1 for this release and its attendant data table. A full all-items data series history for the original index value and for 1-month, 2-month, 3-month, and 12-month percent changes can be accessed via BLS data query tools. A direct link to the all-items series is provided in Table 1 of this release under historical data.

The **South region** is comprised of Alabama, Arkansas, Delaware, District of Columbia, Florida, Georgia, Kentucky, Louisiana, Maryland, Mississippi, North Carolina, Oklahoma, South Carolina, Tennessee, Texas, Virginia, and West Virginia.
